Sydney Branch Talks

7 July 2010 Pay Equity: The 2010 Equal Remuneration Case in Historical Context. (Special General Meeting)

The venue was changed on the night to the Madison Hotel Anne Junor, Professor of Organisation and Management at UNSW spoke of the gender inequities enshrined in industrial agreements since the 1880s and the strategies to be employed to overcome the inequities.

10 March 2011,: Heroes and Villains the Rise and Fall of the Early Australian Labor Party.

Held at Gleebooks, Glebe Pt Rd. Paul Howes, Secretary of AWU launched Sydney Branch Vice President, Nick Dyrenfurth's book. (Sydney Branch member, Bradon Ellem introduced Paul Howes.) It was well attended but there were few members of the Sydney Branch present.
